

**“FLONASE GREATEST SEASON EVER” SWEEPSTAKES
FULL OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. ELIGIBILITY: The GlaxoSmithKline “FLONASE Greatest Season Ever” Sweepstakes (“Sweepstakes”) is open only to legal U.S. residents of the 50 United States (including D.C.), who are at least 18 years of age or the age of majority in their jurisdiction of residence, whichever is greater, at the time of entry. Employees (and household family members of such employees) of GlaxoSmithKline Consumer Healthcare (“Sponsor”) and their respective parents, affiliates, subsidiaries and advertising, promotion and fulfillment agencies or agencies associated with the execution of this Sweepstakes, are not eligible. Internet access is required to participate. The Sweepstakes is subject to all federal, state and local laws and regulations. Void outside the United States and where prohibited or otherwise restricted by law.

2. TERM: The Sweepstakes begins at 12:01:00 a.m. ET on March 23, 2018 and ends at 11:59:59 p.m. ET on March 29, 2018 (“Sweepstakes Period”) and consists of seven (7) daily prize drawings, each with its own entry period that begins at 12:00:00 a.m. ET and ends at 11:59:59 p.m. ET on each calendar date during the Sweepstakes Period (each a “Daily Entry Period”).

3. HOW TO PARTICIPATE: Visit GreatestSeasonEverSweepstakes.com (“Website”) and follow the instructions to register. You may then submit one (1) entry during each Daily Entry Period for a chance to win a prize in that day’s prize drawing. Each entry is only eligible for inclusion in the prize drawing corresponding to the Daily Entry Period during which your entry was received; non-winning entries will not roll over into, or be eligible for, subsequent prize drawings. All entries become the exclusive property of the Sponsor and will not be returned or acknowledged. 4. PRIZES:

Day 1 (March 23, 2018): Twenty (20) prizes will be awarded, each consisting of one (1) \$25 prepaid card. Approximate Retail Value (ARV) of each prize: \$25.

Day 2 (March 24, 2018): Ten (10) prizes will be awarded, each consisting of one (1) \$100 prepaid card. ARV of each prize: \$100.

Day 3 (March 25, 2018): Ten (10) prizes will be awarded, each consisting of one (1) \$150 prepaid card. ARV of each prize: \$150.

Day 4 (March 26, 2018): Five (5) prizes will be awarded, each consisting of one (1) \$250 prepaid card. ARV of each prize: \$250.

Day 5 (March 27, 2018): Three (3) prizes will be awarded, each consisting of one (1) \$500 prepaid card. ARV of each prize: \$500.

Day 6 (March 28, 2018): Two (2) prizes will be awarded, each consisting of one (1) \$1,000 prepaid card. ARV of each prize: \$1,000.

Grand Prize (March 29, 2018): One (1) prize will be awarded, consisting of one (1) \$3,000 prepaid card. ARV of prize: \$3,000.

Total ARV of all Prizes: \$10,750.

5. ODDS: Odds of winning a prize depend on the number of eligible entries received during the corresponding Daily Entry Period.

6. PRIZE CONDITIONS: Limit one (1) prize per person throughout the Sweepstakes Period. 7. DRAWING: Potential prizewinners will be selected in a series of random drawings from among all eligible entries received during the applicable Daily Entry Period. Drawings will be held on or about March 30, 2018. Sponsor will attempt to award all prizes subject to the maximum of five (5) alternate winners and provided the number of entries received for each drawing is equal to or greater than the number of prizes available. The drawing will be conducted by an independent judging agency whose decisions are final and binding. Fulfillment agent will attempt to notify potential winners at the email address provided at registration. Potential winners will be disqualified (subject to Sponsor's discretion) if they fail to timely respond to any notification requesting a response. Sponsor is not responsible for any change of email addresses by entrants or a potential winner's failure to check their Inbox, Junk or other SPAM filters. Each person may only use one (1) e-mail address to enter this Sweepstakes, and such e-mail address may only be used by one (1) person, regardless of whether the e-mail address is shared by two or more people. Any person who uses more than one (1) e-mail address to enter this Sweepstakes or attempts to submit more than one (1) entry during each Daily Entry Period may be disqualified and any prize won may be forfeited, subject to Sponsor's sole discretion. If a dispute arises regarding who submitted an entry, the entry will be deemed to be submitted by the Authorized Account Holder of the e-mail address used at the time of registration. The "Authorized Account Holder" is defined as the natural person who is assigned an e-mail address by an internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any attempts by an individual to enter the Sweepstakes via a bot script robotic program, script, macro, brute-force attack, or other unauthorized means will result in that individual becoming ineligible and such entries disqualified and any prize won will be forfeited. In such event, Sponsor will randomly select winner(s) from among all eligible non-suspect entries received prior to such action. Sponsor reserves the right, at its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these full Official Rules.
